1. 외국회사 특허권자 중국 특허침해소송에서 승소 뉴스

Nordson Wins Two Patent Infringement Lawsuits in Shanghai

Shanghai, China

Nordson Corporation ("Nordson", NASDAQ: NDSN), as the plaintiff, recently received rulings from the Shanghai Intellectual Property Court (the "Court"), against NDC Spray Coating System Fabricating Co., Ltd. ("NDC"), as the defendant, a company located in the Fujian Province, Southeast China. The Court ruled that NDC's products at issue, i.e., NDC Universal Module and the NDC String Nozzle for the application of adhesive onto stretched elastic strands, infringe, respectively, the relevant claims of Chinese Patent No. 02107773.8 (Universal™ Module Patent) and Chinese Patent No. 03812627.3 (SureWrap® Nozzle Patent) owned by Nordson in China. The Court ordered the defendant NDC to immediately cease and desist from infringement on Nordson's relevant patents, and further awarded the plaintiff Nordson damages and reasonable expenses.

Solvay's wholly owned subsidiary, Cytec Industries Inc., prevails in its patent infringement lawsuit in China against Sunshow Specialty Chemical Co. Ltd.

Shenzhen, China – April 3, 2017 --- Cytec Industries Inc., a member of the Solvay Group, announced today that Sunshow Specialty Chemical (Yantai) Co., Ltd. (Sunshow), agreed to compensate Cytec for infringement of its patent in China, No. ZL 02826049.X, covering its CYASORB CYNERGY SOLUTIONS® V703 product for UV stabilization of thermoplastic olefins in automotive applications.

The payout from Sunshow brings an end to the infringement litigation in the Shenzhen Intermediate People's Court, as well as a parallel proceeding by Sunshow for invalidation of the patent in the State Intellectual Property Office, wherein the Reexamination Board's Decision for Invalidation Request No. 31232 maintained Cytec's patent as valid.

Filing Patent Infringement Lawsuit against Ningbo Solartron Technology Co., Ltd Patent infringement relating to LCD backlight film technology

Toray Industries, Inc. (head office: Chuo-ku, Tokyo; President: Akihiro Nikkaku; hereinafter referred to as "Toray") today announced that it filed patent infringement lawsuit against Ningbo Solartron Technology Co., Ltd. in Shenzhen Intermediate People's Court on May 25, 2017. The lawsuit claims infringement of Toray's Chinese Patent No. 201180005983.2 relating to Toray's products of polyester film "Lumirror"™ and seeks injunction barring sales and production of white film relating to LCD backlight reflectors, and collection of damages for the past infringement.

The patent covers polyester films that have features of stiffness, surface shape properties and cushion properties. The polyester films for reflectors that Toray produces, for example "Lumirror"™ E6D8 series, are based on its patent technologies including the Chinese patent technology, and they are widely used in the edge backlight type LCDs widely used all over the world.

Immersion has also filed complaints against Fitbit and its Shanghai-based distributor in China, Runtong International Trade Co., Ltd. ("Runtong") in the Shanghai Intellectual Property Court, alleging infringement of three Immersion Chinese patents.

Filing New Patent Infringement Lawsuit against Ningbo Solartron Technology Co., Ltd

Toray Industries, Inc. (head office: Chuo-ku, Tokyo; President: Akihiro Nikkaku; hereinafter referred to as "Toray") today announced that it filed a patent infringement lawsuit against Ningbo Solartron Technology Co., Ltd.(hereinafter referred to as "Ningbo") in Shenzhen Intermediate People's Court on August 16, 2017. The lawsuit claims infringement of Toray's Chinese Patent No. 200580038463.6 to the product of white film relating by Ningbo with its LCD backlight reflectors (Accused products: DJX188, DJX225B, DJX250B, DJX250P and DJX300P), seeks injunction barring sales and production of the accused products, and collection of damages for the past infringement in China.

The patent has features of specific heat shrinkage properties of white polyester films, and covers white polyester films relating to LCD backlight reflectors widely. The polyester films for reflectors that Toray produces and sells, are based on its patent technologies including the Chinese patent technology, and they are widely used in backlight type LCDs all over the world.

On May 25, 2017, Toray filed a patent infringement lawsuit against Ningbo to seek injunction barring sales and production of DJX300P, and collection of damages for the past infringement in China on the Toray's Chinese patent No. 201180005983.2. The new patent lawsuit by Toray's Chinese Patent No. 200580038463.6 was filed for adding other accused products.

On June 30, 2017, Sumitomo Wiring Systems, Ltd., one of our subsidiaries, filed a lawsuit with the Beijing Intellectual Property Court against Delphi Packard Electric Systems Co., Ltd. and two other companies for infringement of three of its Chinese patent rights regarding automotive wiring harness connectors.

The Sumitomo Electric Group respects its and others' intellectual property rights. In the case of violation of our intellectual property rights, we will take appropriate action, including legal action if necessary.
