General Regulations

The 2008 Samsung ISU World Cup Short Track Competition will be held in accordance with the ISU 2006 General Regulations, Special Regulations, and ISU Communication No.1464. Participation in the World Cup Competition is open to all skaters belonging to an ISU Member.

Program and Distances

- a) Individual distances 2 x 500, 1000 and 1500 meters for Ladies and Men
- b) Relay distances 3000 meters for Ladies and 5000 meters for Men

Track

The track is an artificial refrigerated indoor ice surface which measures 60 x 30 meters; protective padding will cover the boards in accordance with Rule 280, paragraph 5. The standard track 111.12 meters to the lap in accordance with rule 280.

Entries

Entries will be accepted in accordance with ISU Communication 1464. Entries must be sent in writing using the official Entry Forms for the Samsung ISU World Cup Short Track and addressed to the Organizing Committee.

Preliminary Entries, with provisional names, must be submitted by <u>Friday</u>, <u>18 January 2008</u>. Final Entries must be submitted by <u>Friday</u>, <u>1 February 2008</u>.

Competitors must be present in Salt Lake City at the latest at 18:00 on Thursday, 7 February 2008 or the Organizing Committee must receive documented proof that the competitors are in transit and will arrive in due time for the World Cup Competition. Competitors who do not comply with these requirements will be excluded.

Training Times

Ice will be available for training at the Utah Olympic Oval beginning Monday, 4 February 2008 – Wednesday, 6 February 2008. The cost per session is \$8.00 USD per person (approximately 20 skaters per session). Each training session will be 50 minutes in length. The Organizing Committee will assign practice ice times. Official Ice training is Thursday, 7 February and is free to all participants.

Payment for practice ice time must be paid in US Dollars to the Organizing Committee prior to, or at the Team Leaders Meeting on Thursday, 7 February 2008.

Citizenship/Residence requirements and Clearance Procedure

In accordance with Rule 109 and ISU Communication No.1420, all skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate.

Drawing Procedure

The make up of the first qualifying round of each distance shall be based on the current distance ranking following Rule 296, of the 2006 ISU Regulations. Progression to subsequent qualifying rounds shall be according to ISU Rule 295, paragraph 2.

Points

Points will be given in accordance with ISU Communication No.1464, paragraph 9.

Anti-Doping Control

Anti-Doping tests will be carried out in accordance with the valid ISU Anti-Doping Code (ISU Communication No. 1447 and 1448 or any further update of these Communications).

Liability

In accordance with Rule 119, the ISU, U.S. Speedskating, the Utah Olympic Oval, and the Utah Athletic Foundation assume no responsibility for or liability with respect to bodily or personal injury or loss of property or damage incurred in connection with the ISU World Cup Short Track. Each Member is solely responsible for providing insurance coverage thereto.

Board and Lodging

The participating Members are responsible for meals and accommodations for all participants. The cost of the host hotel is \$99.00 USD (single room includes breakfast for 1) and \$109.00 USD (double room includes breakfast for 2). The listed rates are per night and excluding taxes. Teams will be on their own for lunch and dinner with the following exceptions: 1 meal will be provided at the Oval on competition days (Friday-Sunday.) Accommodation requests must be made to the Organizing Committee according to the attached form no later than **Friday**, **18 January 2008**.
